the Honorable City Mayor in her communication dated July 1988 has recommended for the creation of one (1) Liaison Officer in her office which shall be paid in form of monthly stipend or fee at a rate of \$7,000.00 - \$8,000.00 such compensation covers all expenses related to the assignment

WHEREAS, so many indorsements were made regarding the matter;

WHEREAS, on August 22, 1988 the Honorable City Mayor by indorsement clarified that the intention of her office is not for the city to create a permanent position of a liaison officer but rather for the city to retain the services of a person on a contractual basis and requested that she be authorized to enter into a contract with a person of her choice who shall act as liaison officer of the city, and to appropriate the amount required as payment of monthly fee of the liaison officer under contract;

WHEREAS, the Fifth Sangguniang Panlungsod og Ormoc through its Secretary has endorsed the same to the City Legal Officer, calling a new his attention to the 4th indorsement dated August 22, 1988 of the Honorable City Mayor Ma. Victoria L. Locsin, clarifying therein the intention of her good office, for perusal and recommendation;

WHEREAS, on August 25, 1988 the City Legal Officer in his indersement has recommended for the creation by the Sangguniang
