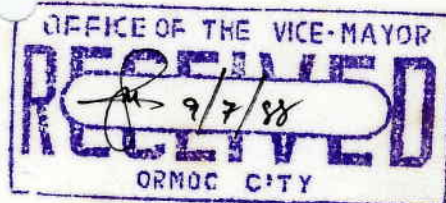

RESOLUTION NO. 86

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO AUTHORIZE THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO UTILIZE THE AMOUNT OF NINE THOUSAND PESOS (P9,000.00) FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) FOR ORMOC CITY'S ANNUAL CONTRIBUTION TO THE LEAGUE OF CITIES OF THE PHILIPPINES, AUTHORIZED PER DLG MEMORANDUM CIRCULAR NO. 88-36 DATED JULY 7, 1988.

WHEREAS, the Honorable City Mayor in her 1st indorsement dated August 22, 1988 has requested for supplemental appropriation the amount of Nine Thousand Pesos (P9,000.00) representing the annual contribution of the City of Ormoc to the League of Cities of the Philippines as agreed upon in the meeting of the National Executive Board authorized per DLG Memorandum Circular No. 88-36 which provides that the respective sangguniang panlungsod of the cities may hereafter, consistent with existing laws and applicable rules and regulations, appropriate such sums as may be necessary out of the funds under P.D. No. 144, as amended, not otherwise appropriated, and other funds as may be available therefor, as contribution to the League of Cities of the Philippines: Provided, however, that no vital projects or program of the city shall be prejudiced;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Celso P. Porcadilla, and Romeo M. Hermosilla; be it

RESOLVED, to earnestly request authorization from the Department of Local Government (DLG), through the Regional Director, Region VIII, Tacloban City, to authorize the Honorable City Mayor Ma. Victoria L. Locsin, to utilize the amount of Nine Thousand Pesos (P9,000.00) from out of the 20% Economic Development Fund (EDF) to be made available for Ormoc City's annual contribution to the League of Cities of the

Philippines, authorized per DLG Memorandum Circular No. 88-36 dated 07 July 1988.


