WHEREAS, the Honorable Sangguniang Panlungsod of Bacolod has furnished this august Body a copy of its Resolution No. 352, Series of 1988, for support, requesting Congress of the Philippines to pass a resolution directing the National Power Corporation (NAPOCOR) to study the possibility of lowering the rates imposed upon local electric cooperatives;

WHEREAS, said resolution is, indeed, very timely considering that about a month ago, no less than the president herself ordered the roll back of gasoline and other oil prices on NAPOCOR's prerogative;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Rodolfo L. Rivilla, Jr. and Benjamin F. Tugonon; be it




