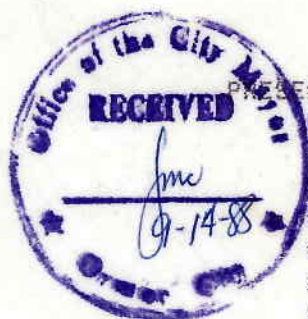

RESOLUTION NO. 88

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 352, SERIES OF 1988

PRESIDENT CORAZON C. AQUINO FOR HER INFORMATION AND PROPER
APPROPRIATE DISPOSITION.

WHEREAS, the Honorable Sangguniang Panlungsod of Bacolod has
furnished this august Body a copy of its Resolution No. 352, Series of
1988, for support, requesting Congress of the Philippines to pass a
resolution directing the National Power Corporation (NAPOCOR) to study
the possibility of lowering the rates imposed upon local electric
cooperatives;

about a month ago, no less than the president herself ordered the roll
back of gasoline and other oil prices on NAPOCOR's prerogative;

Mayor, Ormoc City

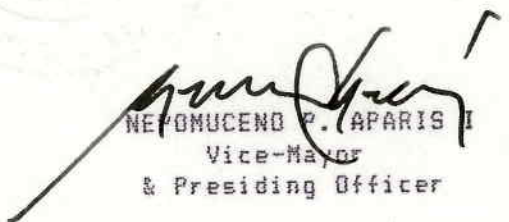

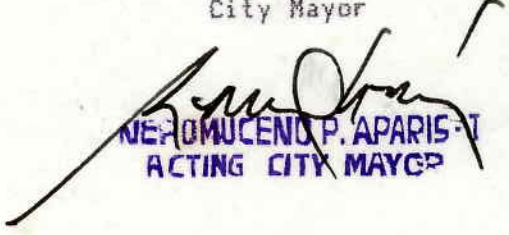
