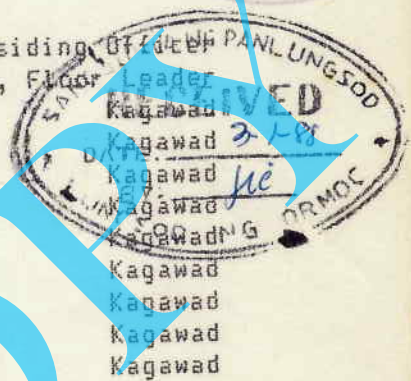

RESOLUTION NO. 9

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN
A DEED OF DONATION IN FAVOR OF ORMOC LAND TRANSPORTATION OFFICE
REPRESENTED BY THE HONORABLE MANUEL N. SABALIA, IN HIS CAPACITY AS
ASSISTANT SECRETARY OF THE DEPARTMENT OF TRANSPORTATION AND
COMMUNICATIONS AN AREA OF 1,500 SQUARE METERS TO BE TAKEN FROM LOT
NO. 2237 HAVING A TOTAL AREA OF 2,269 SQUARE METERS WHICH LOT WAS
EXPROPRIATED BY THE CITY GOVERNMENT UNDER SPECIAL PROCEEDING 711-0
AND DECIDED BY THE COURT OF APPEALS IN CA-G.R.# 36470-R, WHICH
BECAME FINAL AND EXECUTORY ON JUNE 20, 1979.

"WHEREAS, The Honorable City Mayor Maria Victoria L. Locsin has
endorsed to this august Body a communication from the Transportation
District Officer, Mr. Roberto A. Costelo of the Ormoc Land
Transportation Office, Ormoc Field Office, Department of Transportation
and Communications, which quoted hereunder verbatim, to wit:

The undersigned is the incumbent Transportation District Officer of
the Ormoc Land Transportation Office. I would like to bring to your

attention a very important aspect affecting our office which I believe, you would want to know.

The Regional Director sent over yesterday, Mr. Isagani Mariano, our Regional Administrative Officer to inform me that there is now an available allocation from our central office earmarked for the construction of our district office here in the City.

However, he has set the condition that said allocation could only be released if we can show to the central office authorities a deed of donation of a lot in favor of the Land Transportation Office, the area of which is sufficient enough to house not only the office building but also an inspection as well as impounding area for motor vehicles presented for registration as well as those being impounded.

He mentioned to me that the authorities of the central office would very much appreciate if you could effect the donation of a lot of around 1,500 to 2,500 square meters to meet the required standard set by them.

I was made to understand Mom, that the amount allotted for such office is around one million five hundred thousand pesos (P1,500,000.00). I assure you Mom, that with such amount we could construct an office that the people of the City of Ormoc under your administration and leadership could certainly be proud of.

It is therefore precisely for this reason that I am earnestly requesting your good office to please persuade the members of the Sangunian Panglungsod to sponsor a resolution hastening said donation that would undoubtedly promote the best interest and welfare of the City of Ormoc.

Lastly Mom, I trust that this request would merit your kind attention and approval and with your support and encouragement, it is my sincere belief and considered conviction that I will succeed in persuading the authorities concerned to release said amount the soonest possible time so we could immediately start its construction in time to have it inaugurated during the celebration of the fiesta of the City this coming June and with assurances of my highest personal esteem, regards and cooperation, I am.

"WHEREAS, the City is very much willing to donate a lot for all intents and purposes of the Land Transportation Office: PROVIDED, However, that should the Land Transportation Office no longer need or use the lot, it shall be returned to the City together with all the improvements thereon;

"NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, seconded by Kagawad Celso P. Adolfo; be it

"RESOLVED, to authorize the Honorable City Mayor, in behalf of the City Government of Ormoc, to sign a Deed of Donation in favor of Ormoc Land Transportation Office, represented by the Honorable Manuel N. Sabalza, in his capacity as Assistant Secretary of the Department of

Transportation and Communications, an area of 1,500 sq. meters which lot was expropriated by the City Government under Special Proceeding 711-0 and decided by the Court of Appeals in CA-G.R. #36470-R, which became final and executory on June 20, 1979;



"CARRIED UNANIMOUSLY."


