RESOLUTION NO. 91

A RESOLUTION ADOPTING PROVINCIAL RESOLUTION NO. 488, SERIES OF 1988  
OF THE SANGGUNIANG PANLALAWIGAN OF AGUSAN DEL NORTE, VEHEMENTLY  
OBJECTING THE PASSAGE OF HOUSE BILL NO. 5062.

WHEREAS, we are in receipt of Resolution No. 488, Series of 1988  
for our support and indorsement of the Sangguniang Panlalawigan of  
Agusan del Norte, vehemently objecting the passage of House Bill No.  
5062 "An act Authorizing the Secretary of Public Works and Highways to  
Delegate the Implementation of Government Infrastructure and  
Construction Projects to the District Engineering Office of the  
Department concerned Amending for the Purpose Presidential Decree  
Numbered Fifteen Hundred and Ninety-four," Thus:

"Sec. 2-A Authority of Public Works and Highways. - The  
Secretary of Public Works and Highways shall have the authority to  
decide whether a project can be undertaken, and thereby may  
delegate the implementation of the same to, the District  
Engineering Office of the Department concerned; is not only in line  
with the concept of decentralization, but it is extremely  
incontrast with the concept of the present dispensation."

WHEREAS, we conform and concur in the embodiment of said  
Resolution of the Honorable Sangguniang Panlalawigan of Agusan del  
Norte;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr.,  
unanimously seconded; be it

hereby does vehemently object the passage of House Bill No. 5062 called  
for in said resolution;




