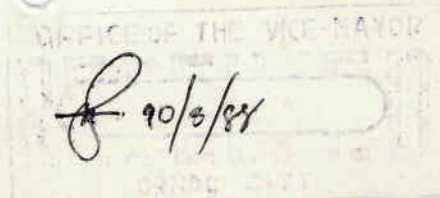

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN
NOT TO GRANT A PERMIT TO RANCO MANAGEMENT CORPORATION TO OPERATE SMALL
TOWN LOTTERY (STL) HERE IN ORMOC CITY.

WHEREAS, Ranco Management Corporation, through its Provincial Assistant
Coordinator, Mr. Filco Arias, has requested for a permit to conduct
experimental Runs of Various Number Games for the Small Town Lottery here in
Ormoc City;

WHEREAS, the Honorable Committees on Trade & Commerce and Social
Welfare submitted the matter for public hearing on the 20th of September,
1988;

WHEREAS, during the public hearing majority of the different sectors of
our society strongly objected the Small Town Lottery operation here in Ormoc
City;

NOW, THEREFORE, on motion of Kagawad Jose B. Conejos, unanimously
seconded; be it

RESOLVED, to request the Honorable City Mayor Ma. Victoria L. Locsin
not to grant a permit to Ranco Management Corporation to operate Small Town
Lottery (STL) here in Ormoc City considering that during the public hearing
jointly conducted by the Honorable Committees on Trade and Commerce and
Social Welfare chaired by the Honorables Sixto T. Pongos and Jose B.
Conejos, respectively, majority of the different sectors of our society
strongly objected for it to operate;


RESOLVED, FURTHER, to furnish a copy of this resolution each to

Station, Ormoc City;


