## RESOLUTION NO. 98

A RESOLUTION TO RESTORE THE POSITION OF ASSISTANT CITY ENGINEER, CITY ENGINEERING OFFICE, ORMOC CITY, WHICH WAS ABOLISHED IN THE APPROVED LOCAL GOVERNMENT REORGANIZATION OF ORMOC CITY EFFECTIVE SEPTEMBER 1, 1988.

WHEREAS, this august Body passed Resolution No. 44, embodying Ordinance No. 13, adopting the Allocation (Placement List); Organization and Position Chart; and the List of Employees affected by the Reorganization, by virtue and in conjunction to Resolution No. 218 dated May 10, 1987 of the previous Third Sangguniang Panlungsod ng Ormoc, adopting and implementing the organizational structure and staffing pattern in the local government of Ormoc as mandated in Section 169 (4) of the Local Government Code, otherwise known as Batas Pambansa Rlg. 337 and in pursuant to NLG Circular No. 83-29 dated December 6, 1983;

WHEREAS, in the approved local government reorganization the position of the Assistant City Engineer in the City Engineering Office was abolished despite the essentiality of the position;

WHEREAS, on September 1, 1988, Engr. Wilfredo A. Fiel, the incumbent Assistant City Engineer communicated to Honorable City Mayor Ma. Victoria L. Locsin, being the Chairman of the Reorganization Committee to the effect that the position of the Assistant City Engineer must be restored in the proposed Reorganization of the City Government Personnel considering that his retention as Asst. City Engineer will not prejudice the interest of the City Government, i.e. its normal operations and functions and he has been in the government with exemplary and very satisfactory performance in more than 22 years of public service;

WHEREAS, acting on the request, Honorable City Mayor Ma. Victoria L. Locsin and Honorable Carmelo J. Locsin, Congressman, 4th District of Leyte, in their 1st and 2nd indorsements dated September 12, 1988 and September 20, 1988, respectively, have endorsed the same to Hon. Gaudioso C. Sosmena, Jr., Executive Secretary (Director), Bureau of Local Government Supervision, for consideration and favorable approval;

WHEREAS, on September 21, 1988 Hon. Gaudioso C. Sosmena, Jr. answered as hereunder quoted verbatim, thus:

Respectfully returned to the City Mayor, Ormoc City, the within letter dated September 1, 1988 of Engr. Wilfredo A. Fiel, Assistant City Engineer, that city, relative to his request for the consideration and approval of the retention of his position which was abolished in the reorganization of the City Government with the information that in view of the representations herein made and the favorable recommendation of Honorable Congressman Carmelo J. Locsin, the Joint Commission agrees with the proposed restoration of the position of Assistant City Engineer since this is deemed an essential position in the Office of the City Engineer, provided, however, that such restoration be embodied in a resolution of the Sangguniang Panlungsod thereof.


