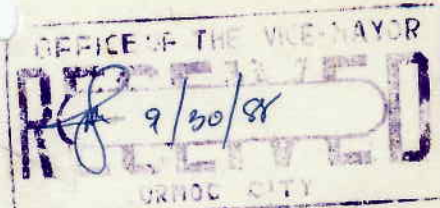

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, seconded by Kagawad Romeo M. Hermosilla; be it

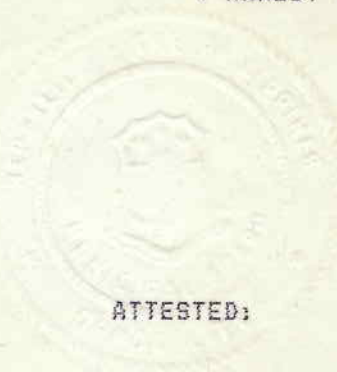
