NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, seconded by Kagawad Arnulfo C. Salazar; be it

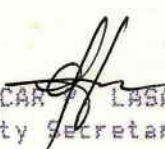

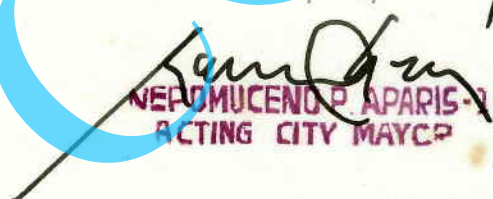
