RESOLUTION NO. 101

A RESOLUTION OF CONDOLENCE TO THE BEREAVED FAMILY AND CLAN OF THE
LATE EX-MAYOR OF ORMOG CITY, HONORABLE ESTEBAN C. CONEJOS, SR.

WHEREAS, this august Body bears the shock with which it takes the
news of the sudden death of a highly esteemed former Mayor of Ormoc
City, Honorable Esteban C. Conejos, Sr., who succumbed in the morning
last July 26, 1989;

WHEREAS, the late Esteban C. Conejos, Sr., who was born and reared
to his early manhood in Tapilon, Daan Bantayan, Cebu, according to
reliable sources, was a self made man with lofty ideals and with
emulative gems of righteousness, courage, simplicity and open-
mindedness;

WHEREAS, reckoning back to his service in the government, Ex-Mayor
Esteban C. Conejos, Sr. was the last appointed Mayor of Ormoc City by
then President Carlos P. Garcia, (1957 to 1959), the first elected Mayor
of Ormoc City from 1959 to 1963, and, was reelected City Mayor of Ormoc
from 1963 to 1967;

WHEREAS, the late Esteban C. Conejos, Sr., with his dedication,
vision and commitment to his job as the former Mayor of Ormoc City, had
won for himself the distinction of a scrupulous worker and a devoted
public servant, faithful to his avowed duties and responsibilities, and,
had greatly helped Ormoc City to its present status of a peaceful,
progressive and beautiful city;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PAMUNGSOD ng
ORMOG, having gravely felt the irreparable loss of a conscientious and
peace loving man and friend, IN SESSION, greatly shares the excruciating
pain and sorrow with Mrs. Rosario B. Conejos, her daughters and sons,
Aumer, Marisa, Linda, Esteban Jr., Manuel, Jose and Rene, respectively,
as well as the anguish and despair with the sister, sons-in-law,

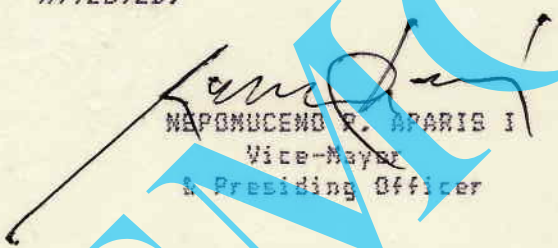
