RESOLUTION NO. 102

A RESOLUTION ADOPTING IN TOTO THE REASONS GIVEN BY THE SANGGUNIANG PANLALAWIGAN OF ILLOCOS NORTE THROUGH ITS RESOLUTION NO. 11-42 S. 1989, EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AGUINO, TO FREEZE OR DEFER THE PROJECTED INCREASE IN THE PRICE OF OIL AND PETROLEUM PRODUCTS.

WHEREAS, The Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 11-42 S. 1989 of the Sangguniang Panlalawigan of Ilocos Norte, earnestly and respectfully requesting Her Excellency, President Corazon C. Aquino, to freeze or defer the projected increase in the price of oil and petroleum products;

WHEREAS, it is true that the projected increase in the price of said products would inevitably cause a chain reaction in the increase of prices of the basic commodities;

WHEREAS, this august Body is in accord with the official reaction of the Sangguniang Panlalawigan of Ilocos Norte which has registered the general sentiment of the people who are with untold hardships and can hardly cope up with the demands of daily sustenance;

WHEREAS, this august Body conforms to the embodiment of the aforesaid resolution of the Honorable Sangguniang Panlalawigan of Ilocos Norte;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by mga Kagawad Arnulfo C. Salazar and Celso P. Porcadilla; be it
