RESOLUTION NO. 103

A RESOLUTION ADOPTING WITH CONDITIONS, RESOLUTION-ORDINANCE NO. 89-001 S. 1989 OF THE SANGGUNIANG PAMBARANGAY OF DON FELIPE LARRAZABAL RE: AN ORDINANCE PROHIBITING THE REPAIR/CONSTRUCTION OF HOUSES WITHOUT THE KNOWLEDGE AND PERMISSION FROM THE PUNONG BARANGAY OR THE KAGAWAD-IN-CHARGE.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 89-04 s. 1989, captioned: Prohibiting the Repair/Construction of Houses without Prior Knowledge from the Barangay Officials, of the Sangguniang Pambarangay of Don Felipe Larrazabal, this city, which resolution having resolved as adopted, Ordinance No. 89-001 re An Ordinance Prohibiting the Repair/Construction of Houses without the Knowledge and Permission from the Punong Barangay or the Kagawad-In-Charge;

WHEREAS, the above resolution-ordinance is pictured out as an appreciative manifestation of the active involvement of the Barangay Officials of Brgy. Don Felipe Larrazabal in solving out problems for the interest and welfare of the community;

WHEREAS, on the score of Issuance or Denial of Permits regarding constructions and/or repairs of houses and the corresponding penalties on violations thereof, there are existing laws being observed to this effect under the responsibilities of the Building Inspector or Building Permit Section of the City Engineer's Office, (and the Licensing Division of the Office of the City Mayor), in accordance with the provisions of the National Building Code;

WHEREAS, this august Body considers justifiable to resolve with compensatory favors the laudable gestures and efforts of the Barangay Officials of said barangay, taking into view, however, the existing laws to this effect;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonson, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Arnulfo C. Salazar and Antero T. Fiel; be it

RESOLVED, to adopt, however, with certain conditions, Resolution-Ordinance No. 87-001 s. 1989 of the Sangguniang Pambarangay of Brgy. Don Felipe Larrazabal of An Ordinance Prohibiting the Repair/Construction of Houses without the Knowledge and Permission from the Punong Barangay or the Kagawad-In-Charge, with the following below as conditions, to wit:

1. Permit (written or oral) granted by the Barangay Chairman/Kagawad-In-Charge shall not be construed in alikeness, both in nature and in substance, with the permit granted by the Building Inspector of the City Engineer's Office.
2. The penalties provided in said Resolution-Ordinance should be entirely removed, and
3. The permit granted by the barangay shall be subject to the permit to be granted by the Building Inspector in accordance with the provisions of the National Building Code.


RESOLVED, FURTHER, that the adoption of the aforesaid Resolution-Ordinance of Brgy. Don Felipe Larrazabal shall be only for purposes of ORDERLINESS in the construction/repair of the houses in said barangay and for the GENERAL WELFARE of the inhabitants living therein;

ENACTED, August 3, 1989.


