RESOLUTION NO. 104

A RESOLUTION ADOPTING RESOLUTION-ORDINANCE NO. 002 S. 1989 OF THE  
SANGGUNIANG PAMBARANGAY OF BRGY. DON FELIPE LARRAZABAL RELATIVE  
REQUIRING ANY PERSON/STUDENT TO GIVE AN AMOUNT AS FEE WHENEVER THEY  
REQUEST FOR BARANGAY CLEARANCE, AND FOR OTHER PURPOSES.

WHEREAS, this august Body is in receipt of Resolution-Ordinance  
No. 002 S. 1989 of the Sangguniang Pambarangay of Don Felipe Larrazabal,  
this city, on "Requiring any Person/Student to give an amount as  
Donation whenever they request for Barangay Clearance, and for other  
purposes";

WHEREAS, the amounts so cited in said Resolution-Ordinance are  
very nominal which, according to the provisions of the Local Government  
Code, are clearly within the powers of a Barangay Council to enact for  
the purpose of raising revenue for the benefit of the barangay;

WHEREAS and however, in the phrase, "to give an amount as  
DONATION", as cited therein, the term "donation" should be changed to  
"fee", for actually, the act of giving something is not in a voluntary  
gesture, rather it is a sort of being obligated with something in  
consideration of something done;

WHEREAS, this august Body considers compensatory to resolve with  
favors the laudable manifestation of the Barangay Officials of said  
barangay;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, duly  
seconded by Kagawad Arnulfo C. Salazar; be it

ENACTED, August 3, 1987.

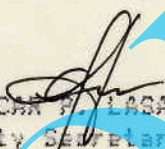

CARRIED UNANIMOUSLY.

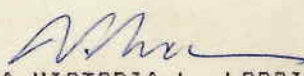
