

RESOLUTION NO. 107

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P17,509.40 FROM OUT OF THE ZOL ECONOMIC DEVELOPMENT FUND FOR THE FUNDING OF THE 2-DAY SEMINAR ON DISASTER PREPAREDNESS OF THE ORMOC CITY DISASTER COORDINATING COUNCIL.

WHEREAS, this august Body is in receipt of the Approved Minutes of the Ormoc City Disaster Coordinating Council held at the Sangguniang Panlungsod - Conference Room on July 31, 1989 which, among others, has requested for an appropriation in the amount of P17,509.40 for the necessary funding of a 2-day Seminar on Disaster Preparedness of said Council to be held on August 15 to 16, 1989 this city;

WHEREAS, the City Budget Officer has recommended that the proposed expenditures for the 2-day Seminar on Disaster Preparedness of the Council in the amount of P17,509.40 be reverted from the ZOL Economic Development Fund to Management Tool account, both Non-Office;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, in a strong belief that the planned Seminar on Disaster Preparedness of the Ormoc City Disaster Coordinating Council is in keeping with the Program of the City Government for continuous and immediate services to its constituents especially in time of emergency, has enacted IN PRINCIPLE of an appropriation amounting to P17,509.40, said amount or so much thereof to be made available for the funding of the aforesaid seminar, the funding source of which is reversion from out of the ZOL Economic Development Fund to Management Tool account, both Non-Office, subject, however, to the approval for this purpose granted by the Department of Local Government;

NOW, THEREFORE, on motion of Magawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mgs. Magawad Eufrocino C. Codilla, Jr. and Celso P. Porcadilla; be it

SALVATIERRA, DLS, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P17,509.40 FROM OUT OF THE POZ ECONOMIC DEVELOPMENT FUND FOR THE NECESSARY FUNDING OF THE 2-DAY SEMINAR ON DISASTER PREPAREDNESS OF THE ORMOC CITY DISASTER COORDINATING COUNCIL;


