A RESOLUTION EARNESTLY REQUESTING THE LAND MANAGEMENT BUREAU,
DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, TO CONDUCT A
SURVEY ON PUBLIC LANDS PRESENTLY OCCUPIED BY RESIDENTS OF BARANGAY
DISTRICT 24.

WHEREAS, this august Body is in receipt of Resolution No. 6, s.
1989 of the Barangay Council of Brgy. District 24, this city, requesting
the City Government through the Fifth Sangguniang Panlungsod ng Ormoc
for a resolution to request the Land Management Bureau, Department of
Environment & Natural Resources, to conduct a survey on public lands
presently occupied by residents in said barangay district;

WHEREAS, aside the aforecited resolution, the Barangay Captain of
said barangay district has officially informed this august Body, through
Honorable Arnulfo C. Salazar, SP Kagawad, that a representation was made
by them with the Department of Environment & Natural Resources,
particularly the Land Management Bureau, of the intention of the
residents in said barangay to qualify themselves as buyers under
miscellaneous sales with the Land Management Bureau, however, with the
pre-condition of a land area survey of all public lands therein occupied
by said residents;

WHEREAS, as further officially informed, before these said public
lands will be surveyed, a resolution from this august Body to this
effect is needed, considering that the Land Management Bureau, will
recommend a necessary amount for the conduct of the survey;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly
seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Benjamin F.
Tugonon; be it
