RESOLUTION NO. 109

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE DONATION OF TWO (2) LOTS, NOW USED BY THE CITY AS ROAD LOTS, PARTICULARLY DESCRIBED AS LOT NO. 11962-A (PART OF T.C.T. NO. 17914) WITH AN AREA OF 11,480 SQ. METERS SITUATED AT BARANGAY DONA FELISA VILLAGE, AND LOT NO. 2, -A PARCEL OF LAND (LOT NO. 11962-C-2-B (PART OF T.C.T. NO. 19439)) CONTAINING AN AREA OF 4,378 SQ. METERS SITUATED AT COGON COMBADO, ORMOC CITY, FROM MRS. AMALIA P. VDA. DE AVILES AND MR. CIRIACO P. AVILES, JOINT OWNERS (DONORS), WHICH TWO PARCELS OF LAND HAVE BEEN DONATED AS ROAD LOTS SUBJECT TO THE CONDITION THAT THESE ROAD LOTS BE PROPERLY MAINTAINED AND DEVELOPED BY THE CITY GOVERNMENT.

WHEREAS, two respectable and civic-minded citizens in Ormoc City, Mrs. Amalia P. Vda. de Aviles and Mr. Ciriaco P. Aviles, mother and son, respectively, have long signified their intention to donate to the City Government of Ormoc, two (2) parcels of land, more particular described as Lot No. 11962-A (Part of T.C.T. No. 17914) with an area of 11,480 square meters, situated at Barangay Dona Felisa Village, and, Lot No. 2, -a parcel of land Lot No. 11962-C-2-B (Part of T.C.T. No. 19439) containing an area of 4,378 square meters situated at Cogon Combado, Ormoc City, in consideration of the improvements (road-right-of-ways and other civil works) to be made by the City Government in the premises, and, as an act of cooperation, liberality and generosity;

WHEREAS, a received letter dated July 27, 1989 from the donors, Mrs. Amalia P. Vda. de Aviles and Mr. Ciriaco P. Aviles, addressed to the Honorable City Mayor of Ormoc, the latter having indorsed the same to the Sangguniang Panlungsod ng Ormoc, through Honorable Arnulfo C. Salazar, Chairman, Committee on Public Properties, said letter has stated that a Deed of Donation in favor of the City Government over the aformentioned premises was then executed sometimes in February, 1984, however, only to be found out lately of having a defect, for the signatory official who represented the City Government was the then City Engineer, rather it should legally be, as per board resolution, the City

Mayor as the rightful official to receive or accept donations for and behalf of the City Government;

WHEREAS, it was also pointed out lately by the Housing and Land Use Regulatory Board that there was no resolution from the Sangguniang Panlungsod ng Ormoc relative having accepted said donation, and, should there be a resolution of acceptance to be enacted, said resolution should reiterate a pledge by the City Government, (as condition), on continued development of roads and other civil works in said premises;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, considers the aforementioned donations by said donors as generous humanitarian gestures, very laudable and much commendable; hence, forthwith be accorded with due course and favorable action;

NOW, THEREFORE, on motion of Kagawad Arnulfo Salazar, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr. and Benjamin F. Tugonon; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE DONATION OF TWO (2) LOTS, NOW USED BY THE CITY AS ROAD LOTS, PARTICULARLY DESCRIBED AS LOT NO. 11962-A (PART OF T.C.T. NO. 17914) WITH AN AREA OF 11,480 SQ. METERS, SITUATED AT BARANGAY DONA FELISA VILLAGE, AND LOT NO. 2, - A PARCEL OF LAND (LOT NO. 11962-C-2-B (PART OF T.C.T. 


