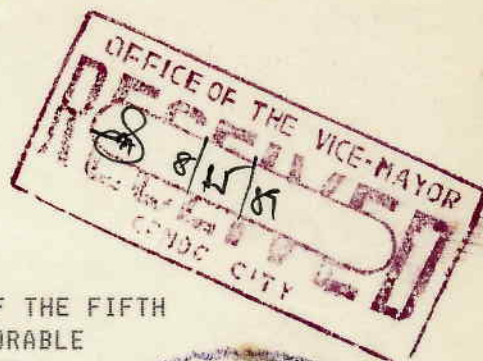
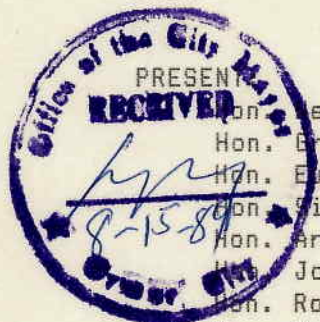

RESOLUTION NO. 110

A RESOLUTION AMENDING ITEM "CONFERENCE TABLE" TO READ AS "EQUIPMENT OUTLAY" IN THE 1989 ANNUAL BUDGET OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE, ORMOC CITY, WITHOUT, HOWEVER, CHANGING ITS ORIGINAL APPROPRIATION OF P3,000.00, TO GIVE WAY TO THE PURCHASE OF CHAIRS INSTEAD OF A CONFERENCE TABLE.

WHEREAS, this august Body is in receipt of a letter-request dated July 22, 1989 from Ms. J. A. Dlojan, City Social Welfare Officer, DSWD, Ormoc City, that said Office be allowed to purchase chairs from out of the 1989 Annual Budget as appropriated by the City Government amounting to P3,000.00 due to the increasing Office Staff personnel;

WHEREAS, the City Budget Officer has recommended for a resolution amending Item "Conference Table" in the 1989 Annual Budget of DSWD to read as "Equipment Outlay" without, however, changing its original appropriation in the amount of P3,000.00;

WHEREAS, this august Body considers the request of DSWD Office reasonable, and, the recommendation of the City Budget Officer tenable, to give way to the purchase of chairs in lieu of a Conference Table;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to pass a resolution to amend Item "Conference Table" in the 1989 Annual Budget of the Department of Social Welfare and Development Office to read as "Equipment Outlay" without, however, changing its original appropriation of P3,000.00, to give way to the request of said Office to purchase chairs instead of a Conference Table;






