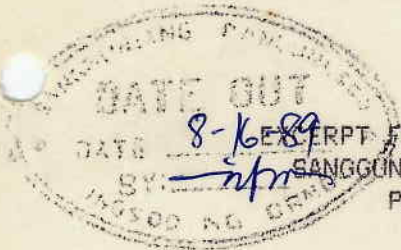
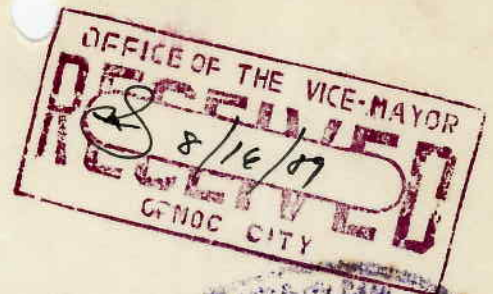

RESOLUTION NO. 112

A RESOLUTION CREATING FOUR (4) NEW POSITIONS UNDER THE CITY PLANNING AND DEVELOPMENT OFFICE, THIS CITY, NAMELY: THE URBAN PLANNER, THE SENIOR PROJECT DEVELOPMENT ANALYST, THE PROJECT EVALUATION OFFICER AND THE CIVIL REGISTRY OFFICER I, ALL SUBJECT TO THE APPROVAL OF THE JOINT COMMISSION ON LOCAL GOVERNMENT PERSONNEL ADMINISTRATION, (JCLGPA).

WHEREAS, this august Body is in receipt (thru channel), of a letter from Engr. N. C. Penserga, Coordinator, City Planning & Development Office, this city, requesting for the creation of additional positions in said Office, alleging therein that one basic problem confronting said Office is the lack of personnel (or manpower) to handle government programs, planning and implementation;

WHEREAS, Her Honor, the City Mayor, has favorably recommended for official legislation of the creation of the following new positions in the City Planning & Development Office, namely: the Urban Planner, the Project Evaluation Officer and the Senior Project Development Analyst;

WHEREAS, also considering the necessity and importance of creating the new position of a Civil Registry Officer I in the same Office, the City Budget Officer, through the Chairman, Committee on Finance, has also recommended to this august Body of one additional creation, i.e., the creation of said Civil Registry Officer I;

WHEREAS, the corresponding Salary Grades of the aforestated proposed positions are not emphasized herein, taking into view of the current trend and plan of the government on upgrading the salaries of all government employees, generally, or, of possibly applying a new scheme or Revised Standardization of Salaries to meet current demands or factors, and, the JCLGPA Office is believed one of the first Offices in the government to know all about these current developments;

WHEREAS, the City Treasurer, this city, has certified to the availability of funds to meet payments for the Personal Services requirement of the proposed new positions under the City Planning & Development Office;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, considers the request of the Coordinator, CPDO, very reasonable, thus, forthwith be given due course and immediate action;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr. and Celso P. Porcadilla; be it
