RESOLUTION NO. 114

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P2,432,300.00 FROM OUT OF REVERSION OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND TO THE ACCOUNTS: GENERAL PUBLIC SERVICES (MANAGEMENT TOOL), HEALTH NUTRITION & POPULATION CONTROL, HOUSING & COMMUNITY DEVELOPMENT, AND ECONOMIC SERVICES- AGRICULTURAL DEVELOPMENT PROJECTS, THE SAID AMOUNT TO BE MADE AVAILABLE AS FUNDING REQUIREMENT FOR IMPLEMENTATION ON PROGRAMMED DEVELOPMENT PROJECTS OF THE 1989 ORMOC CITY DEVELOPMENT PLAN ON PROPOSED PROJECTS UNDER THE 20% ECONOMIC DEVELOPMENT FUND, AS REVISED.

WHEREAS, as per letter from the City Coordinator, City Planning & Development Office, this city, that the Regional Director, Department of Local Government, Tacloban City, has made a directive emphatically mandating compliance of the local unit ON PROGRAMMING the 20% Economic Development Fund of Ormoc City, in view of its being used as emergency fund;

WHEREAS, the City Treasurer did inform this august Body that the Balance of the 20% Economic Development Fund of Ormoc City as of June 30, 1989 is P3,203,153.64;

WHEREAS, the City Development Council in a meeting called for the purpose, has deliberated and agreed to appropriate an amount of Two Million Five Hundred Eighty Five Thousand Three Hundred Pesos, (P2,585,300.00), from out of the existing EDF Balance to finance the following development projects of the city, to wit:

1. General Public Services (Management Tool):
 - Construction of City Nursery - P100,000.00
 - Training of Lupon Tagapayapa - 42,300.00
 - Training of newly elected
Barangay Captains/Councilmen - 153,000.00
 - Revision of Ormoc City profile - 25,000.00
 - Update DLG briefing folder - 5,000.00
 - LG - Crop Training - 15,000.00

2. Health Nutrition & Population Control:

WHEREAS, the City Budget Officer has further recommended for the passage of a resolution requesting authority from the DLG Regional Director, Tacloban City, for the utilization of the 20% Economic Development Fund amounting to P2,585,300.00 for the proposed projects as above identified in Items a,b,c, & d ;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGBOD ng ORMOc, in SESSION, has formally deferred the approval of one (1) subject matter under the item: General Public Services (Management Tool), i.e., Training of the newly elected Barangay Captains/Councilmen amounting to P153,000.00, on ground of impropriety or doubtful reasonableness of the proposed amount, subject to further yet immediate deliberations, and, for the DLG City Development Office personnel to shade more light or justifications on the subject matter at issue;

WHEREAS, this august Body, in keeping with the program of the City Government for continuous and immediate services to its constituents in pursuance with its Development Objectives, (Underscoring Supplied), has enacted Resolution No. 113 embodying Appropriation Ordinance No. 89-40, (a copy of which is hereto attached), approving IN PRINCIPLE of an appropriation of TWO MILLION FOUR HUNDRED THIRTY TWO THOUSAND THREE HUNDRED PESOS & 00/100, (P2,432,300.00), (i.e., P2,585,300.00 less P153,000.00), from out of reversion of the 20% Economic Development Fund, (EDF), to the following accounts: General Public Services (Management Tool), Health Nutrition & Population Control, Housing & Community Development, and Economic Services- Agricultural Development Projects, the said amount or so much thereof to be made available as funding requirement for implementation on programmed development projects of the 1989 Ormoc City Development Plan on Proposed Projects under the 20% Economic Development Fund, as revised, SUBJECT, HOWEVER, TO AN AUTHORIZATION FOR THIS PURPOSE GRANTED BY THE DEPARTMENT OF LOCAL GOVERNMENT;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Rodolfo L. Rivilla, Jr. and Celso P. Porcadilla; be it

RESOLVED. to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P2,432,300.00, (i.e., P2,585,300.00 less P153,000.00), FROM OUT OF REVERSION OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND TO THE FOLLOWING ACCOUNTS: GENERAL PUBLIC SERVICES (MANAGEMENT TOOL), HEALTH NUTRITION & POPULATION CONTROL, HOUSING & COMMUNITY DEVELOPMENT, AND ECONOMIC SERVICES- AGRICULTURAL DEVELOPMENT PROJECTS, the said amount to be made available as funding requirement for implementation on programmed development projects of the 1989 Ormoc City Development Plan on Proposed Projects under the 20% Economic Development Fund, as revised;
