


RESOLUTION NO. 115

A RESOLUTION ENDORSING AND SUPPORTING RESOLUTION NO. 89-07-304, S.  
1989 OF THE CITY COUNCIL OF OROQUIETA, REQUESTING CONGRESS TO ENACT  
MEASURES EFFECTING TRANSFER OF CONTROL AND SUPERVISION OF COCKPITS  
FROM THE GAMEFOWL COMMISSION TO LOCAL GOVERNMENT UNITS.

WHEREAS, the City Council of Oroquieta has furnished this august  
Body of its Resolution No. 89-07-304, s. 1989 for indorsement and  
support, requesting Congress of the Philippines to enact measures  
effecting transfer of control and supervision of cockpits from the  
Gamefowl Commission to local government units;

WHEREAS, this august Body conforms to the embodiment of the  
aforesaid resolution which, among other reasons, -that the control and  
supervision of cockpits operation be under the local government units so  
that collections derived therefrom could be plowed back for improvements  
of the respective local government units as well as the regulation of  
the operation thereof;
