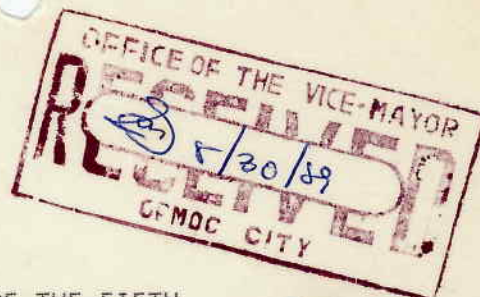

RESOLUTION NO. 116

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT A
DONATION FROM MR. JESUS CAPUYAN AND MS. OFELIA YEE TO THE CITY
GOVERNMENT OF ORMOC, OF A PARCEL OF LAND LOT NO. 2273-H-I OF THE
CADASTRAL SURVEY OF ORMOC, COVERED BY TCT NO. 2552, WITH AN AREA OF
1,164 SQUARE METERS, SITUATED AT BRGY. ALEGRIA, ORMOC CITY, AND,
THANKING THE DONORS FOR THEIR CIVIC-MINDEDNESS AND GENEROSITY.

WHEREAS, two civic-spirited citizens in Ormoc City, Mr. Jesus
Capuyan and Ms. Ofelia Yee, have signified their intention to donate a
parcel of land to the City Government of Ormoc, more particularly
described as Lot No. 2273-H-I of the Cadastral Survey of Ormoc, covered
by TCT No. 2552, containing an area of 1,164 square meters, situated at
Brgy. Alegria, Ormoc City;

WHEREAS, a Deed of Donation has been executed to this effect
between the Donors and the Donee, the latter to make improvements in
said premises, like road-right-of way and other civil works, and, as an
