

RESOLUTION NO. 118

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P130,000-00 FROM OUT OF REVERSION OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE GENERAL FUND TO THE ACCOUNT: GENERAL PUBLIC SERVICES (MANAGEMENT TOOL), THE SAID AMOUNT TO BE MADE AVAILABLE AS FUNDING REQUIREMENT FOR IMPLEMENTATION ON A PROGRAMMED DEVELOPMENT PROJECT RE: TRAINING OF NEWLY ELECTED BARANGAY CAPTAINS/COUNCILMEN OF THE 1989 ORMOC CITY DEVELOPMENT PLAN ON PROPOSED PROJECTS UNDER THE 20% ECONOMIC DEVELOPMENT FUND, AS REVISED.

WHEREAS, the proposed project on Training of Newly Elected Barangay Captains and Councilmen in Ormoc City was temporarily escaped or not included in the submitted List of Development Projects as programmed for the included in the submitted 1989 City Development Plan of Ormoc City per Sangguniang Panlungsod Resolution No. 113 embodying Appropriation Ordinance No. 89-40, for the reason that the original amount of P153,000.00, as earlier proposed for the said project was officially deferred pending further deliberations relative the propriety or reasonableness of said proposed amount of P153,000.00;

WHEREAS, the Honorable SANGGUNIANG PANLUNGSOD ng ORMOC, in its latest regular SESSION, Wednesday, August 23, 1989, after thorough deliberations, has come up with the following Financial and Budgetary requirements justifying the newly approved (reduced) appropriation amounting to One Hundred Thirty Thousand Pesos, (P130,000.00), for this project on the Training of Newly Elected Barangay Captains/Councilmen, which justifying requirements run as follows:

WHEREAS, the City Budget Officer has recommended that the financial requirement of One Hundred Thirty Thousand Pesos, (P130,000.00), for the project re Training of Newly Elected Barangay Captains & Councilmen be reverted from the 20% Economic Development Fund to the account - General Public Services (Management Tool);

WHEREAS, the Honorable SANGGUNIANG PANLUNGSOD of ORMOC considers necessary to restate its collective intention in here that this development project on the Training of Newly Elected Barangay Captains/Councilmen with the approved appropriation of P130,000-00 be incorporated as additional project to the submitted List of Proposed Projects as programmed under the 20% Economic Development Fund of the 1989 Ormoc City Development Plan;

WHEREAS, this august Body, in keeping with the program of the City Government for continuous and immediate services to its constituents, has enacted Resolution No. 117 embodying Appropriation Ordinande No. 89-d1, (a copy of which is hereto attached), approving IN PRINCIPLE of an appropriation of ONE HUNDRED THIRTY THOUSAND PESOS, (P130,000.00), from out of reversion of the 20% Economic Development Fund (EDF) to the following account: General Public Services (Management Tool), the said amount or so much thereof to be made available as funding requirement for implementation on a programmed development project re: Training of Newly Elected Barangay Captains/Councilmen of the 1989 Ormoc City Development Plan on Proposed Projects under the 20% Economic Development Fund, as revised, SUBJECT, HOWEVER, TO AN AUTHORIZATION FOR THIS PURPOSE GRANTED BY THE DEPARTMENT OF LOCAL GOVERNMENT;
