## RESOLUTION NO. 119

A RESOLUTION EARNESTLY REQUESTING THE LAND MANAGEMENT BUREAU, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, TO CONDUCT A SURVEY OF THE PUBLIC LANDS PRESENTLY OCCUPIED BY THE RESIDENTS OF BARANGAY SAN ISIDRO, ORMOC CITY, FOR PURPOSES OF PROCESSING SALES PATENT OR PRE-PATENT, AS THE CASE MAY BE.

WHEREAS, this august Body is in receipt of Resolution No. 1 s. 1989 of the Barangay Council of Brgy: San Isidro, Ormoc City, earnestly requesting a public land surveyor to conduct a survey of the public lands occupied by the residents therein:
