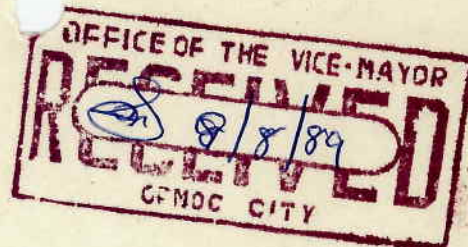

RESOLUTION NO. 121

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY PROSECUTOR TO REPRESENT THE CITY GOVERNMENT OF ORMOC IN IMMEDIATELY FILING OPPOSITION PAPERS TO THE APPLICATION FOR IMMEDIATE AND EMERGENCY RATE ADJUSTMENT (INCREASE) ON LOCAL TELEPHONE BASIC SERVICES FILED BY THE PHILIPPINE ASSOCIATION OF PRIVATE TELEPHONE COMPANIES, INC., (PAPTELCO), WITH DATE OF NOTICE OF HEARING, SEPTEMBER 14, 1989, AT THE NATIONAL TELECOMMUNICATIONS COMMISSION, QUEZON CITY.

WHEREAS, the Honorable SANGGUNIANG PANLUNGSOD ng ORMOC is in receipt of an Application for Immediate and Emergency Rate Adjustment (Increase) on Local Telephone Basic Services filed by the Philippine Association of Private Telephone Companies, Inc., (PAPTELCO), at the National Telecommunications Commission, Quezon City, and, with the Date of Notice of Hearing relative said application on Thursday, September 14, 1989 at said National Telecommunications Commission in Quezon City;

WHEREAS, this august Body considers the proposed monthly adjustment rate on telephone basic services unreasonable, hence, collectively registers its opposition;


