a letter dated September 5, 1989 from Honorable Judge F. H. Escaño, Jr., Executive Judge, RTC, 8th Judicial Region, Branch 12, Ormoc City, addressed to Honorable Congressman Carmelo J. Locsin, 4th District, Leyte, a copy purposely furnished the Henorable SANGGUNIANG PANLUNGSOD ng ORMOC, requesting for a creation of one (1) more Regional Trial Court sala in Ormoc City to fully materialize the Court's adopted measures to administer justice speedily and competently as possible, in line with the present thrust of the government;
