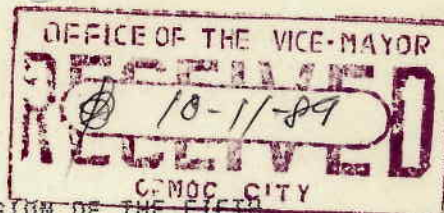

RESOLUTION NO. 124

A RESOLUTION REORGANIZING THE STANDING COMMITTEES OF THE FIFTH
SANGGUNIANG PANLUNGSOD NG ORMOC, AND, AMENDING FOR THIS PURPOSE
RESOLUTION NO. 6, SERIES OF 1988.

WHEREAS, upon two motions presented separately by Kagawad Arnulfo C. Salazar, Chairman, Committee on Internal Rules, that 1) the Committee on Agriculture & Agrarian Reform be changed to the Committee on Agricultural Labor & Agrarian Reform, and, 2) the Committee on Labor be modified to the Committee on Industrial Labor Sector, to pave the way on accommodating areas of jurisdiction and responsibility to the (2) newly appointed mga Kagawad of the Sangguniang Panlungsod ng Ormoc representing the Agricultural Labor and the Industrial Labor sectors of the community, which two motions by their numbers, above, were duly seconded by mga Kagawad Benjamin F. Tugonon and Celso P. Porcadilla, and by Kagawad Celso P. Porcadilla, respectively, and, further, were duly approved by this august Body in SESSION on September 7, 1989;

WHEREAS, by virtue of the Appointments issued by the Honorable Secretary of Local Government, the following three (3) new mga Kagawad, namely: Honorable Edgar I. Palugod, Honorable Solomon S. Chu and Honorable Nelson DL Geneston, to represent the official positions and capacities as ABC President, Representative- Agricultural Labor Sector, and Industrial Labor Sector Representative, respectively, are to assume into office as mga Kagawad - Members of the Honorable Sangguniang Panlungsod ng Ormoc, the Fifth Sangguniang Panlungsod ng Ormoc, having entered upon the exercise of its functions, feels that it would be to the essential services of the Local Government of Ormoc if it reorganizes itself into Standing Committees, amending for this purpose Resolution No. 6 s. 1988, to handle and study matters in consonance with the duties and functions falling under the general jurisdiction of each and every committee, for representation to and deliberation by this august Body, namely: the Committees on Agricultural Labor Sector & Agrarian Reform, Cities Sisterhood Program, Cottage Industries, Education & Cultural Development, Energy Development & Conservation, Environmental Control, Finance, General Services, Good Government & Ethics, Health & Public Welfare, Infrastructure, Internal Rules, Industrial Labor, Laws & Ordinances, Manpower Development, Market & Slaughterhouse, Natural Resources, Police, Fire & Public Safety, Public

Information, Public Properties, Rural Development & Barangay Affairs, Social Welfare, Sports Development, Steering, Tourism, Trade & Commerce, Transportation & Communications, Urban Development, Ways & Means, Youth Development, and Zoning & Beautification;
