RESOLUTION NO. 131

A RESOLUTION REQUESTING THE HONORABLE CITY PROSECUTOR TO FILE A  
MOTION OF DISMISSAL OF A SPECIAL CIVIL ACTION NO. 2842-0 FILED BY  
RANCO MANAGEMENT CORPORATION AGAINST THE CITY OF ORMOC, REPRESENTED  
BY ITS SANGGUNIANG PANLUNGSOD, VICE MAYOR, CITY MAYOR, ET. AL.,  
BEFORE THE REGIONAL TRIAL COURT, BRANCH 12, ORMOC CITY.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc in line with  
its earnest and sincere desire to curb down gambling, to get rid of the  
pernicious effects thereof and to defend the people's general welfare,  
has enacted Resolution No. 165 embodying Ordinance No. 16 on December  
22, 1988, banning the Small Town Lottery, or STL, in its operation in  
Ormoc City;

WHEREAS, the Ranco Management Corporation, represented by Robert  
Juson, has questioned the validity of the aforementioned Resolution-  
Ordinance and has filed a Special Civil Action No. 2842-0 before the  
Regional Trial Court, Region VIII, Branch 12, Ormoc City, against the  
City of Ormoc, represented by its Sangguniang Panlungsod, Vice Mayor,  
City Mayor, et. al., as respondents;

WHEREAS, this august Body has received lately a true copy of  
Memorandum Circular No. 18 from Mr. F. O. Carrascoso, Jr., General  
Manager, Philippine Charity Sweepstakes Office, Manila, addressed to Mr.  
A. Sierra, General Manager, Ranco Management Corporation, Re:  
Cancellation of Authority to Conduct Experiments for the Small Town  
Lottery Project of the PCSO in all existing areas, (i.e., including  
Ormoc City), EFFECTIVE 15 August 1989, and, in conformity with the power  
and prerogative of the Philippine Charity Sweepstakes Office under  
Republic Act No. 1169, as amended by Batas Pambansa Blg. 42, and the

Deed of Authority dated 7 July 1989 issued to Ranco Management Corporation, "continuance of the experiments beyond the period of cancellation is no longer authorized and shall be unlawful";


