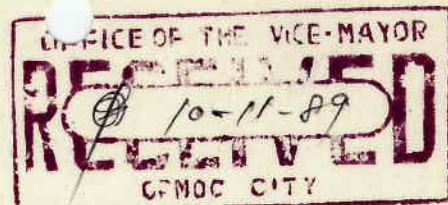

RESOLUTION NO. 135

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORNOC CITY TO UTILIZE THE AMOUNT OF P35,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO DEFRAY THE OPERATIONAL EXPENSES AND PRIZES OF THE INTER-BARANGAY SPORTSFEST ON OCTOBER 20, 1989, ORNOC CITY CHARTER DAY '89 CELEBRATION.

WHEREAS, a letter dated October 4, 1989 of Kagawad N. DL. WHEREAS, the City Budget Officer has recommended that the aforementioned request of P35,000.00 for Inter-Barangay Sportsfest - City Charter Day '89 be funded from the 20% Economic Development Fund of the General Fund;

WHEREAS, the Honorable MEMBERS of the SANGBUNIANG PANLUNGSOD ng ORMOG, IN SESSION, considers that the said Sportsfest is in line with the government program on having our YOUTH positively involved by themselves in sports and athletic activities to make them bodily and mentally strong, for them to be less submissive to vices, thus, has enacted Resolution No. 134 embodying Appropriation Ordinance No. 89-47, (Item B), (a copy of which is hereto attached), approving IN PRINCIPLE of an appropriation of THIRTY FIVE THOUSAND PESOS, (P35,000.00), from out of the 20% Economic Development Fund (EDF) of the General Fund, SUBJECT, HOWEVER, TO THE APPROVAL FOR THIS PURPOSE GRANTED BY THE DEPARTMENT OF LOCAL GOVERNMENT;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P35,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND to defray for the operational expenses and prizes of the INTER-BARANGAY SPORSTFEST on October 20, 1989 to be conducted in connection with the City Charter Day '89 celebration;
