RESOLUTION NO. 138

A RESOLUTION SUPPORTING THE PASSAGE OF SENATE BILL NO. 884 AS SPONSORED BY SENATOR ERNESTO MACEDA, AND, FOR THIS PURPOSE, APPROVING IN TOTO RESOLUTION NO. 667 S. 1989 OF THE SANGGUNIANG PANLUNGSOD NG DAVAO, DAVAO CITY.

WHEREAS, this august Body is in receipt of Resolution No. 677 s. 1989 of the Sangguniang Panlungsod ng Davao, requesting for support and indorsement of the passage of Senate Bill No. 884;

WHEREAS, said Senate Bill No. 884 as sponsored by Senator Ernesto Maceda is now pending in Congress entitled: "A BILL LIMITING THE GROUNDS FOR SUSPENSION AND REMOVAL OF ELECTIVE LOCAL OFFICIALS, PROVIDING THE VENUE OF HEARING AND INVESTIGATION, REQUIRING PRELIMINARY HEARING BEFORE THE ISSUANCE OF PREVENTIVE SUSPENSION, LIMITING THE PERIOD OF SUSPENSION, BOTH PREVENTIVE AND AS A PENALTY, PROHIBITING THE IMPOSITION OF ADDITIONAL PREVENTIVE SUSPENSIONS, AND PROVIDING FOR A DIRECT APPEAL TO THE SUPREME COURT, AMENDING FOR THE PURPOSE SECTION SIXTY, SIXTY-TWO, SIXTY-THREE, SIXTY-FIVE AND SIXTY-SIX OF BATAS PAMBANSA BILANG THREE HUNDRED THIRTY SEVEN, AS AMENDED";

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, IN SESSION, conforms to the propriety and embodiment of the aforesaid resolution of the local legislative body of Davao City;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, duly seconded by Kagawad Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to pass a resolution SUPPORTING THE PASSAGE OF SENATE BILL NO. 884 AS SPONSORED BY SENATOR ERNESTO MACEDA, and do, as this Body hereby does, APPROVE IN TOTO RESOLUTION NO. 677 S. 1989 of the SANGGUNIANG PANLUNGSOD ng DAVAO, Davao City;
