RESOLUTION NO. 142

A RESOLUTION AMENDING FOR THE PURPOSE RESOLUTION NO. 1796 S. 1985 OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOC RE DECLARING A PORTION OF CARLOS TAN STREET, FROM CORNER REAL STREET TO A PORTION OF MABINI STREET UP TO THE CORNER OF OSMENA STREET, AS A ONE-WAY TRAFFIC FOR MOTOR VEHICLES, TO THE EFFECT THAT THE COVERAGE AS TO TIME WILL NOW BE FROM 6:00 O'CLOCK IN THE MORNING TO 6:00 O'CLOCK IN THE AFTERNOON DURING SCHOOL DAYS.

WHEREAS, Resolution No. 1796 s. 1985 was enacted by the then Second Sangguniang Panlungsod ng Ormoc on July 23, 1985 upon a written request of the Directress of Saint Paul's School, this city, declaring a portion of Carlos Tan Street, from corner Real Street to a portion of Mabini Street up to the corner of Osmena Street, as one-way vehicular traffic from 7:30 A.M. to 12:30 P.M. during school days, making said portions of Carlos Tan and Mabini Streets safe for school children from exposure to traffic hazards;

WHEREAS, the Barangay Officials of Brgy. District XXIII, per their Resolution No. 020 s. 1989, has requested this august Body for amendments of the aforementioned Resolution No. 1796 s. 1985, alledging that nowadays, the school's student population has swelled and said school has both morning and afternoon sessions, rendering S.P. Resolution No. 1796 quite inappropriate for the present situation;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly/seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Celso P. Porcadilla; be it


