A RESOLUTION FULLY ENDORSING AND SUPPORTING RESOLUTION NO. 275 S. 1989 OF THE SANGGUNIANG PAMALAMIGAN NG BATANGAS, EXPRESSING STRONG SUPPORT FOR THE PASSAGE OF A BILL INTRODUCED BY SENATOR TEOFISTO GUINGONA GRANTING LOCAL GOVERNMENTS THE AUTHORITY TO FRANCHISE, LICENSE OR REGULATE THE USE OF THREE-WHEELED VEHICLES.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 275 s. 1989 of the Sangguniang Panlalawigan ng Batangas, expressing strong support for the passage of a bill introduced by Honorable Senator Teodoro Guingona granting Local Governments the authority to franchise, license or regulate the use of three-wheeled vehicles;

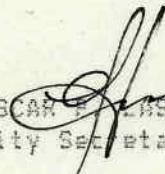

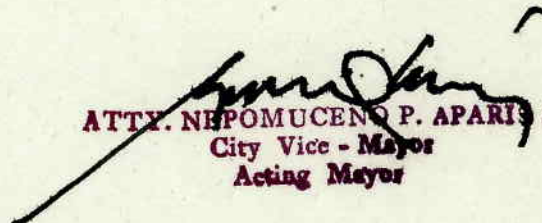
