

RESOLUTION NO. 144

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, ON A LEASE APPLICATION WITH MR. ANTONIO S. VELASQUEZ FOR A SPACE OF NOT MORE THAN 50 SQUARE METERS ON A VACANT LOT AT THE SHOPPING MALL AND FRONTING THERETO, ALONGSIDE FILIPINO BAKERY.

WHEREAS, a letter dated July 28, 1989 of Mr. A. S. Velasquez, addressed to Her Honor, the City Mayor, requesting to rent a space of not more than 50 square meters on a vacant lot of the Shopping Mall along the side of Filipino Bakery;

WHEREAS, the Honorable Vice-Mayor, in his capacity as Acting City Mayor, has endorsed the aforesaid letter to the Honorable Sangguniang Panlungsod ng Ormoc for appropriate action;

WHEREAS, in said letter, the applicant has cited that the City Government has the option to terminate the occupancy of the proposed lessee from the subject lot any time it needs the premises;

WHEREAS, the purpose of the leasehold application is for the supposed lessee to operate a movable hamburger stand to serve the buying public with sanitary and wholesome food and drinks;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Arnulfo C. Salazar; be it
