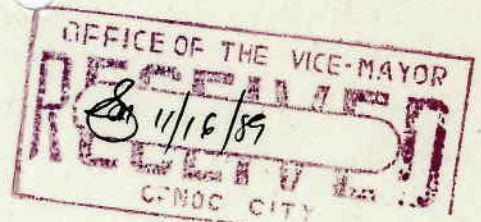

RESOLUTION NO. 146

A RESOLUTION ENDORSING WITH FULL SUPPORT THE PASSAGE OF HOUSE BILL NO. 27057, AS INTRODUCED BY HONORABLE CONGRESSMAN EMIGDIO S. TANJUAATCO, JR., ENTITLED, "AN ACT TO REGULATE THE PRICES OF BASIC NECESSITIES AND PRIME COMMODITIES AND TO ESTABLISH MEASURES TO AVERT OR STOP UNDUE INCREASES IN THEIR PRICES DURING OCCASIONS OF CALAMITY, PUBLIC EMERGENCY OR PREVALENT ILLEGAL PRICE MANIPULATION."

WHEREAS, this august body is in receipt of House Bill No. 27057 entitled "An Act to regulate the prices of basic necessities and prime commodities and to establish measures to avert or stop undue increases in their prices during occasions of calamity, public emergency or prevalent illegal price manipulation", as sponsored by Honorable Emigdio S. Tanjuatco, Jr.;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, conforms to the propriety and embodiment of said House Bill No. 27057;

NOW, THEREFORE, on motion of Kagawad Celso P. Porcadilla, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Gregorio A. Yrastorza, Jr.; be it

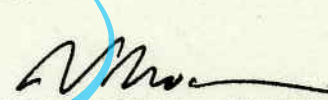
