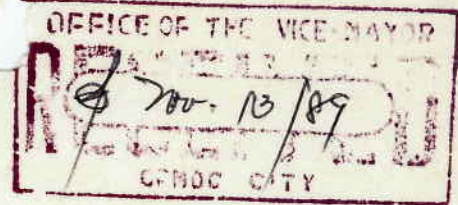
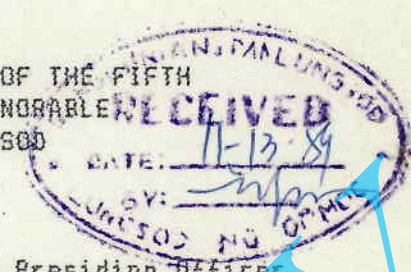

RESOLUTION NO. 149

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CHAIRMAN, BOARD OF TRUSTEES, ORMOC CITY TECHNOLOGICAL MANPOWER AND RESEARCH CENTER, TO ADVISE MANPOWER PROGRAM SUPERVISOR ROMEO M. HERMOSILLA TO STRICTLY OBSERVE OFFICE HOURS FROM 8:00 TO 12:00 A.M. AND FROM 1:00 TO 5:00 P.M. DURING REGULAR DAYS, AND NOT TO MAKE SAID CENTER AS HIS RESIDENCE.

WHEREAS, the Ormoc City Technological Manpower and Research Center is in effect a government office or entity created by virtue of Resolution No. 933 s. 1981 embodying Ordinance No. 27 of the Sangguniang Panlungsod ng Ormoc, with its Board of Trustees as the Policy Making Body to take charge in the administration, control and supervision of all programs and activities of the said Center;

WHEREAS, according to very reliable sources, the incumbent Manpower Supervisor of the aforementioned Center has reportedly been utilizing said Center both as an office and a residence, -a manifestation and practice unbecoming and inimical to public interest;

WHEREAS, Office Order No. 23-88 dated March 30, 1988 from the Office of the City Mayor, addressed to all Department Heads, said directive having "enjoined all concerned against prolonged stay in respective offices during prohibited periods unless officially authorized by the City Mayor, upon the recommendation of supervising department heads. This practice would not only result to additional expenses to the City Government but would likewise pose additional security risks and losses";




