RESOLUTION NO. 153



RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH
ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF
ORMOC TO UTILIZE THE AMOUNT OF P23,000.00 FROM OUT OF THE 20%
ECONOMIC DEVELOPMENT FUND TO DEFRAY FOR THE EXPENSES ESTIMATED
TO BE INCURRED IN FORTHCOMING REGIONAL DEVELOPMENT ASSEMBLY AND
REGIONAL DEVELOPMENT COUNCIL MEETINGS, SOMETIME THIS MONTH,
NOVEMBER, 1989, IN ORMOC CITY AS HOST CITY.

WHEREAS, Art. X, Sec. 14 of the New Philippine Constitution states
that: "The President shall provide for regional development councils X X
X composed of local government officials, regional heads of departments
and other government offices, and representatives from non-governmental
organizations within the region for purposes of administrative
decentralization X X X to accelerate the economic and social growth and
development of the units in the region";

WHEREAS, Executive Order No. 308 and Executive Order No. 366, both
series of 1989, are Presidential directives providing for the
reorganization of the Regional Development Council, (hereafter referred
to as the Council), and, the creation in every region of the country a
Regional Development Assembly, (hereafter referred to as the Assembly),
respectively;

WHEREAS, the aforementioned Executive Orders Nos. 308 and 366
provide, among others, and RESPECTIVELY, to make the RDC (or Council) a
more effective instrument for regional development, consistent with the
constitutional mandate, and, for RDA (or Assembly) to serve as a forum
for the review and validation of the annual and multi-year
infrastructure programs for the region which require appropriation of
national government funds, as recommended by the RDC; for the RDA,
through consensus, to endorse these regional programs for inclusion in
the national infrastructure programs and budgets to be submitted to
Congress for appropriation of funds;

WHEREAS, the Honorable Acting City Mayor, vice Her Honor, the City
Mayor, the latter being out-of-town on official business, has requested
for supplemental appropriation in the amount of P23,000.00 representing
total estimated expenses for the forthcoming Regional Development

(RES. NO. 153)

Assembly (RDA) and Regional Development Council (RDC) meetings scheduled to take place within this month of November, 1989, in Ormoc City as the Host City;

WHEREAS, the City Budget Officer has recommended that the financial requirement of the aforesaid appropriation of P23,000.00 to defray the expenses estimated to be incurred in said RDA and RDC meetings to be hosted by the City Government of Ormoc in Ormoc City at unspecified dates within this month of November, 1989, can be sourced from the 20% Economic Development Fund (EDF) of the General Fund;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted in PRINCIPLE, Appropriation Ordinance No. 89-53, (copy of same is hereto attached), appropriating the amount of TWENTY THREE THOUSAND PESOS, (P23,000.00), said amount or so much thereof to be made available to defray the expenses as estimated for the forthcoming RDA and RDC meetings scheduled conducted within this month of November, 1989, in Ormoc City as Host City, to be taken from the 20% Economic Development Fund (EDF) of the General Fund, subject, however, for approval for these purposes by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by Kagawad Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to pass a resolution REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT, THROUGH REGIONAL DIRECTOR RESURRECCION S. SALVATIERRA, DLG, REGION VIII, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P23,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO DEFRAY FOR THE EXPENSES ESTIMATED TO BE INCURRED IN FORTHCOMING REGIONAL DEVELOPMENT ASSEMBLY (RDA) AND REGIONAL DEVELOPMENT COUNCIL (RDC) MEETINGS, SOMETIME THIS MONTH, NOVEMBER, 1989, IN ORMOC CITY AS HOST CITY;
