

RESOLUTION NO. 154

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE REGIONAL DIRECTOR, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, (DSWD), TACLOBAN CITY, ALLOWING THE USE OF LOT NO. 5127-B, SITUATED IN BRGY. LINAQ, ORMOC CITY, COVERED BY TCT NO. 20407, CONTAINING AN AREA OF 11,858 SQUARE METERS, TO BE UTILIZED AS RESETTLEMENT SITE FOR C.O.R.E. SHELTER ASSISTANCE BENEFICIARIES.

WHEREAS, a letter dated November 20, 1989 from Ms. J. A. Olojan, City Social Welfare Officer, DSWD, Ormoc Branch, Ormoc City, addressed to Her Honor, the City Mayor, said letter having informed that DSWD Regional Office - Tacloban had increased the number of units of CORE Shelter Assistance from 30 to 50 units intended to typhoon victims, (typhoons Unsang and Yoning) whereby their dwellings structures are still unlivable, and, further informing that the total sum of Two Hundred Seventy Thousand Pesos, (P270,000.00), will be released to Ormoc City through DSWD Special Disbursing Officer for the purchase of housing materials for the CORE beneficiaries and, that carpentry tools are already delivered to DSWD Ormoc from DSWD Regional Office;

WHEREAS, the aforesaid letter has further cited that in consultation with Engr. D. Pareja, Geodetic Engineer, City Engineering Office, the 50 units at 80 square meters/family beneficiary (as a requirement) can still be accommodated in a proposed lot, (as counterpart of the City Government), so then has earnestly requested for immediate negotiation on the utilization of said proposed lot so that site development can start immediately;

WHEREAS, said letter has been endorsed to the Honorable Sangguniang Panlungsod ng Ormoc, through the Honorable Executive Officer, City Disaster Coordinating Council and, to the Honorable Chairman, Committee on Public Properties, for further study and appropriate recommendation;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Gregorio A. Yrasterza, Jr. and Sixto T. Pongos; be it


