RESOLUTION NO. 157

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P30,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE AS THE CITY'S AID/CONTRIBUTION TO THE PEACE AND ORDER COUNCIL.

WHEREAS, this august Body is in receipt of a letter dated November 20, 1989 from the Honorable Chairman and the Honorable Vice Chairman of the Peace and Order Council (POC), this city, earnestly requesting for financial assistance in the amount of P30,000.00 to be disbursed for the establishment of Special Operations, such as the creation of Bantay Bayan organizations and other groups in concerned barangays, to counter the growth of insurgency in some barangays already identified as infiltrated by insurgents;

WHEREAS, the City Budget Officer has recommended that the funding requirement of P30,000.00 to cover for the city's aid/contribution to the Peace and Order Council can be funded from the 20% Economic Development Fund of the General Fund;

WHEREAS, this august Body believes that the subject appropriation of P30,000.00, as requested by POC, is very essential and ultimately beneficial for the promotion and maintenance of peace and orderliness in some segments of the community, which peace-loving members thereof are oftentimes disturbed or molested by subversive elements whose ultimate purpose and tendencies are to topple the present democratic government and processes of the Republic;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted Resolution No. 156 embodying Appropriation Ordinance No. 89-55 (Item B), (a copy of same is hereto

attached), approving in PRINCIPLE of an appropriation of THIRTY THOUSAND PESOS, (P30,000.00), from out of the 20% Economic Development Fund (EDF), said amount to be made available to cover for the city's aid/contribution to the Peace and Order Council, SUBJECT, HOWEVER, TO THE APPROVAL FOR THIS PURPOSE BY THE DEPARTMENT OF LOCAL GOVERNMENT;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH REGIONAL DIRECTOR RESURRECCION S. SALVATIERRA, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P30,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND, the same amount to be made available to cover for the city's/contribution to the PEACE AND ORDER COUNCIL;
