RESOLUTION NO. 158

A RESOLUTION ENDORSING WITH FULL SUPPORT THE PASSAGE OF SENATE BILL NO. 1212 AS SPONSORED BY SENATOR ERNESTO H. HERRERA, AND, FOR THIS PURPOSE, APPROVING IN TOTO RESOLUTION NO. 1420 S. 1989 OF THE SANGGUNIANG PANLUNGSDOD NG CEBU CITY.

WHEREAS, this august Body is in receipt of Resolution No. 1420 s. 1989 of the Honorable Sangguniang Panlungsod ng Cebu, requesting for support and concurrence of the passage of Senate Bill No. 1212;

WHEREAS, said Senate Bill No. 1212 as sponsored by Senator Ernesto H. Herrera calls for the restoration of death penalty on drug pushers and traffickers by making certain crimes in the Dangerous Drugs Act of 1972 as "heinous crimes";

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSDOD ng ORMOC, in SESSION, conforms to the propriety and embodiment of the aforementioned resolution of the local legislative body of Cebu City;
