

## RESOLUTION NO. 159

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A CONTRACT FOR SERVICES WITH ANY LAWYER TO REPRESENT THE CITY GOVERNMENT. AS ITS CITY LEGAL COUNSEL.

WHEREAS, a 1st Indorsement Letter dated September 19, 1989 of the Joint Commission on Local Government Personnel Administration, Manila, (by its Assistant Director E. V. Cayudong, Bureau of Local Government Supervision,), addressed to the Honorable City Mayor of Ormoc, informing Her Honor, the City Mayor that " X X X an abolished position (of a City Legal Officer) cannot be re-created within two (2) years from its abolition. Be that as it may, it is suggested that in lieu of a reclassification action, the City Government in the meantime may create a contractual position of Legal Counsel whose rate shall not exceed the salary of a city department head due to the exigency of the service";

WHEREAS, in view of the aforesaid action taken by the Joint Commission on Local Government, Her Honor, the City Mayor, has requested in writing, (3rd Indorsement dated October 19, 1989, subsequently, a Letter dated November 24, 1989), the Honorable Sangguniang Panlungsod ng Ormoc for the following:

- An authority to enter into a contract for services with a legal counsel X X X x .
- An appropriation ordinance in the amount of P10,000.00 representing the contract fee for the month of December, 1989.
