RESOLUTION NO. 16

A RESOLUTION RESPECTFULLY ADDRESSED TO HER EXCELLENCY, PRESIDENT
CORAZON C. AQUINO, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES,
THROUGH THE PRESIDENTIAL MANAGEMENT STAFF, EARNESTLY REQUESTING
FUNDING FROM OUT OF THE PRESIDENTIAL SOCIAL FUND, FOR THE
CONSTRUCTION OF SCHOOL BUILDINGS IN SOME BARANGAYS OF ORMOC CITY.

WHEREAS, Her Honor, the City Mayor, Honorable Ma. Victoria L.
Lorcin, has requested in writing the Honorable Members of the
Sangguniang Panlungsod for a resolution requesting funding from out of
the Presidential Social Fund of Her Excellency, President Corazon C.
Aquino, President of the Republic of the Philippines, for the
construction of school buildings in some of the barangays of Ormoc City,
in connection with the official information secured from a
Representative of the Presidential Management Staff who had paid a
courtesy call at the City Mayor's Office, this city, and informed the
Honorable City Mayor about a funding source for selected projects,
included in it, the funding source for the construction of school
buildings for barangays;

WHEREAS, the Honorable Members of the Sangguniang Panlungsod ng
Ormoc, in session, gladly considers the above request very meritorious,
for it is in keeping with the projects development and plans of the City
Government and of the very probable materialization of some selected
projects due to the possibility of a reliable source of funding;

has already set, proposed plans and identified schedules where barangay
school buildings have to be constructed, availing thereof the funding
source from out of the Presidential Social Fund, (PSF);
