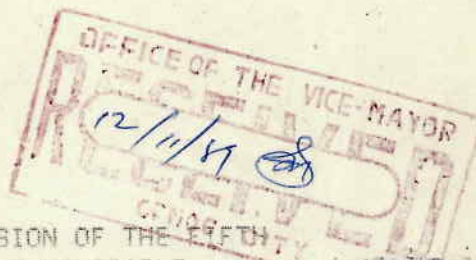

A RESOLUTION SUPPORTING RESOLUTION NO. 868 S. 1989 OF THE SANGGUNIANG PANLUNGSOD NG DAVAO, SAID RESOLUTION HAVING ENDORSED WITH FULL SUPPORT RESOLUTION NO. 87 S. 1989 OF THE SANGGUNIANG PANLUNGSOD NG BUTUAN, ENTITLED, "A RESOLUTION URGENTLY REQUESTING THE SENATE AND THE HOUSE OF REPRESENTATIVES TO ENACT A LAW EXEMPTING LOCAL GOVERNMENTS FROM REMITTING EIGHTEEN (18) PERCENT OF THEIR GENERAL FUND ANNUAL INCOME TO THE INTEGRATED NATIONAL POLICE (INP)".

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 868 s. 1989 of the Sangguniang Panlungsod ng Davao, which resolution has also endorsed with full support Resolution No. 87 s. 1989 of the Sangguniang Panlungsod ng Butuan, entitled, "A Resolution Urgently Requesting the Senate and the House of Representatives to Enact a Law Exempting Local Governments from Remitting Eighteen (18) Percent of their General Fund Annual Income to the Integrated National Police (INP)";

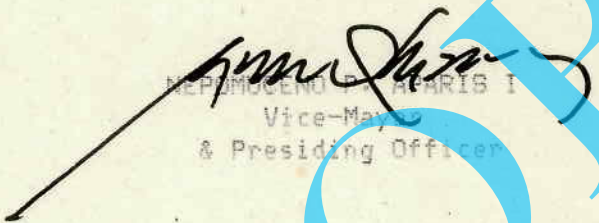
