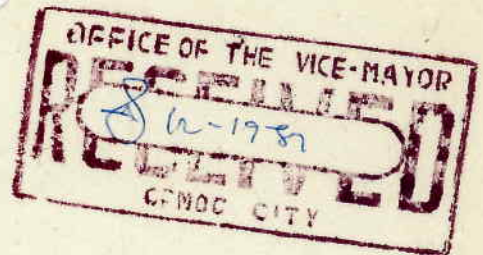

WHEREAS, aside recommendation for the creation of new positions in
the different offices of the City Government of Ormoc, as contained in a
letter dated December 14, 1989 from Her Honor, the City Mayor and


