THROUGH THE PRESIDENTIAL MANAGEMENT STAFF, EARNESTLY REQUESTING
FUNDING FROM OUT OF THE PRESIDENTIAL SOCIAL FUND, FOR THE
CONSTRUCTION OF POTABLE WATER SUPPLY SYSTEM UNDER THE PROJECT:
"TULUNGAN SA TUBIGAN" IN SOME BARANGAYS OF ORMOC CITY.

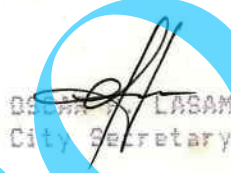

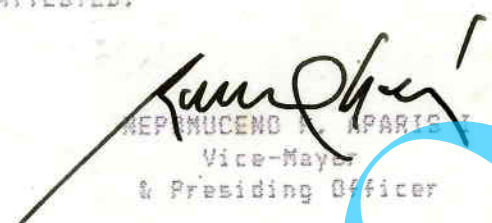
