RESOLUTION NO. 170

A RESOLUTION REQUESTING AUTHORITY FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT, MANILA, THROUGH THE REGIONAL DIRECTOR, DBM, TACLOBAN CITY, TO ALLOW THE CITY GOVERNMENT OF ORMOC TO EXCEED BY TWENTY-ONE PER CENT (21%) OVER THE FORTY-FIVE PER CENT (45%) SALARY LIMITATION OF THE GENERAL FUND FOR 1990.

WHEREAS, P.D. 477 s. 1974, Sec. 28(a) provides that "the total annual appropriation for salaries and wages of X X X, city X X X officials and employees for one fiscal year shall not exceed forty-five per cent (45%), in the case of all first and second class X X X, cities X X X, of the total annual income actually realized from regular sources during the next preceding fiscal year or the current fiscal year estimates from the same sources certified as collectible by the X X X city treasurer concerned, whichever is lower";

WHEREAS, 2nd paragraph of Sec. 28(a), P.D. 477 s. 1974 further provides that "the Secretary of the Department of Budget and Management, however, may authorize appropriations in excess of the percentages hereinabove fixed subject to such conditions as he may impose, but in no case shall the excess in appropriations for salaries and wages be more than twenty-five per cent (25%) of the maximum expendable amounts nor shall such exemption be granted in case of overdraft or imminence thereof";

WHEREAS, as per submitted Computations of Budgetary Requirements - Budget Year 1990, jointly by the City Treasurer and the City Budget Officer, it appears that the total annual appropriation for salaries and wages of city officials/employees for one fiscal year has exceeded forty five per cent (45%) of the total annual income actually realized from regular sources during the next preceding fiscal year, (1988), and, of the necessity to exceed by twenty one per cent (21%) over the forty-five per cent (45%) salary limitation of the General Fund for 1990;


