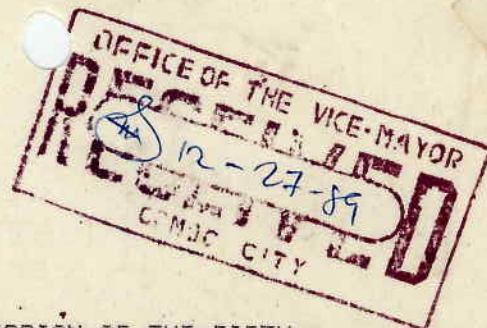

WITHIN THE PREMISES IN BARANGAY DONGHOL, ORMOC CITY";

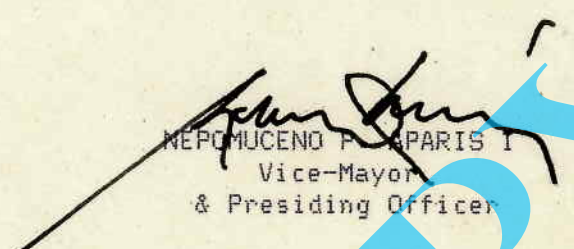

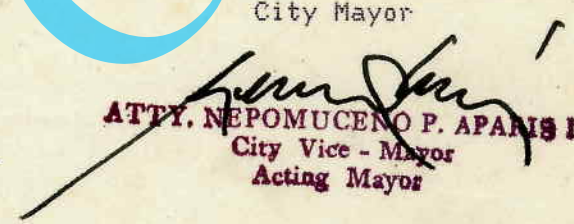
