WHEREAS, the 5th Sangguniang Panglungsod ng Ormog conforms and concurs to the embodiment of said resolution of the City Council of Oramiz;

NOW, THEREFORE, on motion of Kagawad and Floor Leader Gregorio A. Yrasterza, Jr., severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Arnulfo C. Salazar and Celso P. Porradilla; be it

RESOLVED, to adopt in toto Resolution No. 6, s. 1989 of the City Council of Oramiz, urging the House of Senate to approve a bill obliging all business establishments, whether they be principal or branch offices, to remit or pay their national taxes, fees and other licenses in the respective Local Government Units where they are actually operating;
