
RESOLUTION NO. 19.

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE SUM OF P2,100.00 AGAINST CURRENT APPROPRIATION FOR AID TO IMP-ORMOG SUB-STATION RE PAYMENT OF THE CLAIM OF COL. BIONY VENTURA OF RECOM 8 AS REIMBURSEMENT OF THE PURCHASE OF SEVEN HUNDRED (700) PIECES M-16 AMMUNITIONS USED DURING THE TRAINING OF THE CIVILIAN VOLUNTEERS ORGANIZATION, (CVO).

WHEREAS, the Assistant City Treasurer, for and in behalf of the City Treasurer, this city, has requested in writing the Honorable Members of the Sangguniang Panlungsod for the reimbursement of a claim of Col. Denny Ventura, Provincial Commander of RECOM 8, in the amount of TWO THOUSAND ONE HUNDRED PESOS (P2,100.00), for the purchase of seven hundred (700) pieces of M-16 ammunitions used during the training of the Members of Civilian Volunteers Organization, (CVO), at Camp Downes, Ormoc City;

WHEREAS, the aforementioned claim for reimbursement of P2,100.00 was already reflected per Voucher No. 404 dated January 27, 1989, however, through oversight, as alleged thereof, was not taken up among the accounts to be obligated;

WHEREAS, the City Budget Officer and the City Auditor have favorably recommended for a resolution of reimbursement of the aforesaid sum, and, by way of specification, the City Auditor has invoked Section 177, sub-section (aa) of the Local Government Code which provides that the Sangguniang Panlungsod shall "(aa) appropriate money for purposes not specified by law, having in view the general welfare of the city and its inhabitants", and, it appearing that such a kind of training of the civilian volunteers had redound to the general welfare of the inhabitants of Ormoc City in the form of improved peace and order condition;

Diony Ventura of RECOM 8 as reimbursement of the purchase of seven hundred (700) pieces of M-16 ammunitions used during the training of the Members of the Civilian Volunteers Organization;

ENACTED, February 2, 1989.


