RESOLUTION NO. 2

A RESOLUTION EARNESTLY URGING THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO CHOOSE ORMOC CITY AS ONE OF THE PILOT AREAS OF THE RURAL WATERWORKS SAFETY AND SANITATION PROGRAM (RWSSP) BEING LAUNCHED BY SAID DEPARTMENT.

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc is in receipt of the communication from Acting City Mayor Hon. Nepomucenc P. Aparis I, requesting, among others, passage of a Resolution urging the Department of Local Government (DLG) to choose Ormoc City as one of the pilot areas of this Rural Waterworks and Sanitation Program (RWSSP) beginning 1989;

WHEREAS, this program is to be started with eight (8) pilot cities and be selected from different local government units;

WHEREAS, the Hon. City Mayor Ma. Victoria L. Locsin and Members of the Fifth Sangguniang Panlungsod ng Ormoc have signified their intentions and desires to avail of this program considering the importance and benefits that will go to depressed barangays of Ormoc City without having sufficient potable water supply;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., severally seconded by Mga Kagawad Eufroino C. Codilla, Jr., Rodolfo L. Rivilla, Jr., and Antero T. Fiel; be it

RESOLVED, to earnestly urge the Department of Local Government (DLG), to choose Ormoc City as one of the pilot areas of the Rural Waterworks Safety and Sanitation Program (RWSSP) being launched by said department;

RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Secretary of Department of Local Government, Manila; the Regional Director, Department of Local Government, Tacloban City; Her Honor, the City Mayor, Ormoc City; and the Senior Local Government Officer, City Development Office, Ormoc City;
