RESOLUTION NO. 28

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE 1988 CLAIM OF CODILLA'S ENTERPRISES ON PURCHASED MATERIALS USED IN BARANGAY NUEVA SOCIEDAD, ORMOG CITY, IN THE AMOUNT OF P309.25 AGAINST CURRENT APPROPRIATION FOR COMMUNITY AND SCHOOL AIDS OF THE CITY MAYOR'S OFFICE.

WHEREAS, this august Body is in receipt of a letter dated February 10, 1989 from Mr. Bienvenido S. Matiga, Senior Community Affairs Officer, the same letter is with favorable indorsement from the Office of the City Mayor, requesting for the passage of a resolution authorizing the City Treasurer to charge the amount of Three Hundred Nine Pesos & 25/100 (P309.25), against Current Appropriation for Community and School Aids of the City Mayor's Office, which amount to correspond Voucher No. 403 dated January 27, 1989 re: purchased materials from Codilla's Enterprises for the construction of library tables, etcetera, at Inaad Community School, Barangay Nueva Sociedad, Ormog City;

WHEREAS, the City Budget Officer, too, favorably recommends for the passage of a required resolution, chargeable against Current Appropriation for Community and School Aids of the City Mayor's Office;
